**CREATED BY CIVIC-MINDED INDIVIDUALS** as a primary source of grants to address the emerging needs in the community, The Fund for Columbus supports organizations and initiatives identified by the Community Research and Grants Management team.

The funds are distributed through *Giving Strength*, our competitive grantmaking process, where local nonprofits submit proposals for projects and request funding. The Foundation thoroughly assesses and evaluates the nonprofits and programs to determine need and capacity of the program before distributing funds.

**GETTING STARTED IS EASY.**

The Fund for Columbus is a personalized fund you create to impact our community for generations to come. You can use cash, stock, or other assets gifted during your lifetime or at death to establish a named fund, qualify for an immediate income or estate tax deduction, and the Foundation will distribute grants that address our community’s most pressing need.
